EX.CO Ultimate Euro Prediction Challenge Terms

The following are the terms and conditions of the EX.CO Ultimate Euro Prediction Challenge (the "Promotion" and the "Terms"), which is sponsored by EX.CO Technologies Ltd. ("Company", "us" or "we" or "our"). Participation in the Promotion shall be subject to the provisions below and the Company's Terms and Conditions ("Company's Terms and Conditions"). The Terms and the Company's Terms and Conditions shall be collectively referred to as the "Promotion Terms". All collection and processing of personal information as part of or in connection with participating in the Promotion is subject to and governed by our Privacy Policy ("Privacy Policy").

In addition, the Promotion is provided through the "Penka" mobile application ("**Penka App**") and your use of the Penka App is governed by <u>Penka's Terms and Conditions</u> and <u>Penka's Privacy Policy</u> ("**Penka's Terms**").

By participating in the Promotion, you hereby represent and warrant that you have read and shall be bound by the Promotion Terms and any and all other terms and conditions relating to the Promotion. In the event you do not agree to be bound by the Promotion Terms, or any amendment thereto, you must not participate or otherwise take part in the Promotion or to withdraw and discontinue your participation in the Promotion.

General

- 1. The Promotion shall commence on June 1, 2024 and conclude on July 14, 2024, at 10:00 PM CET (the "**Promotion Period**").
- 2. You agree that in order to participate in the Promotion (including, without limitation, in order to win any reward), you will fully comply with all applicable laws, regulations, statutes, ordinances and provisions that apply to you and to us, including, without limitation, the Promotion Terms.
- 3. There is no cost to enter the Promotion, or any obligation associated with participating in it, except as described below.

Eligibility

- 1. In order to participate in the Promotion you must be a resident of one of the following countries: United Kingdom, Norway, Denmark, Sweden, Spain and limited US states (where legally permitted) ("Eligible Countries"), and you hereby represent and warrant that you: (i) have an account registered with Penka; (ii) are at least 18 years old (or older, as applicable); (iii) reside in one of the Eligible Countries; (iv) are eligible under applicable law to participate in the Promotion; (v) have the full right and authority to participate in the Promotion.
- 2. You may not use multiple email addresses, accounts or identities or any other method in order to participate in the Promotion more than once.
- 3. You may not register on behalf of another person.
- 4. You may be asked at any time to provide us or our designated third party with proof of your age and/or identity and/or residency and you must, on demand, be able to present a valid

- 5. Company's employees (including, without limitation, part-time or temporary employees), officers, and representatives, promotion agencies and/or sponsors directly involved in the administration, development, fulfilment, and execution of the Promotion, and the immediate family and other household members (i.e., spouses, parents, grandparents, children, grandchildren, roommates, housemates, significant others, partners, and siblings) of any of the above are not eligible to enter and/or to win the Promotion.
- 6. If you are unable to uphold these Promotion Terms, including by providing satisfactory documents, we may, at our sole reasonable discretion and at any time (both during the Promotion Term or afterwards, as applicable), exclude you from the Promotion and you may be required to forfeit any privileges or awards that have been allocated to you without compensation of any kind. You hereby irrevocably waive any claims or rights in connection with any such exclusion and/or forfeiture.

How to enter the Promotion and win the Prize

- 1. The Promotion consists of the prediction of the results of the Euro tournament matches. Each correct guess of a match result shall earn the participant a single point. The participant who accumulated the highest number of points during the Promotion Period (i.e., had the highest number of correct guesses) shall be declared the winner and shall be eligible to win the Prize (as defined below). If several participants have earned the same number of points, the Prize will be equally divided between the eligible winners.
- 2. The odds of winning are based on the number of eligible entries.
- 3. During the Promotion Period, you may apply to participate in the Promotion by visiting the Promotion page at: https://content.ex.co/euro-2024 We will review your application, and if we determine that you are eligible to participate in the Promotion, you will receive an email containing a link to the Penka App and a code for participating in the Promotion. Following that, you will be required to download the Penka App, create an account with the same email you registered with on the above link, and follow the links and instructions for entering the Promotion. The Penka App, which can be downloaded free of charge, requires an internet connection and a compatible device. For further information, please visit Penka's website.
- 4. You must enter the Promotion during the Promotion Period in order to be eligible to win the Prize (as defined below).
- 5. Any requests for participation that do not comply with the foregoing may be disqualified or void at our sole reasonable discretion. No other form or method for submitting an entry will be considered, unless otherwise set forth in this Promotion Terms.
- 6. The choice of winners is final and binding, unless stated otherwise in these Promotion Terms.
- 7. Entries received that are from ineligible entrants or do not comply with these Promotion Terms will be considered void. Entries that are determined to be fraudulent will be considered void, and the person making such entry may be barred from participation in the Promotion and, in Company's sole discretion on a case-by-case basis, banned from any future participation in any future Company's promotions and/or services. Proof of sending or submission will not be deemed to be proof of receipt. You hereby agree than in no event will you have any claims against us for any submissions that were not received or acknowledged by us, for any reason whatsoever, or which were received before or after the Promotion Period.

- 8. Company reserves the right at its sole discretion, and at any time, to disqualify any individual who is found to be (i) acting in violation of the Promotion Terms or (ii) acting in an unsportsmanlike or disruptive manner, with the intent to disrupt or undermine the legitimate operation of the Promotion, or with the intent to annoy, abuse, threaten or harass any other person. Without limiting the foregoing, in the event the Company is prevented from continuing with the Promotion as contemplated by any event beyond their control, including, without limitation, a force majeure, fire, flood, epidemic or other national health emergency, earthquake, explosion, labour dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared,) or any federal, state or local government law, order, or regulation, order of any court or jurisdiction, public health crisis, or other cause not reasonably within its control, then Company shall also have the right to modify, suspend, extend or terminate the Promotion. In the event that the Promotion is terminated, cancelled, or postponed for any reason whatsoever, the actual value of the Prize will be awarded to the extent required by law.
- 9. Without limiting the foregoing, the Company may lock out any participant who, in Company's sole judgment, has been disqualified, has questionable eligibility, or is otherwise ineligible to participate in the Promotion. Any person who attempts to undermine or interfere with the legitimate operation of the Promotion may be subject to civil and/or criminal penalty, and Company reserves the right to seek damages from any such person to the fullest extent permitted by law.

All changes shall be made known prior to the beginning of the Promotion Period. You acknowledge that you shall be responsible for staying up to date with any and all changes made to the Promotion. Your continued participation in the Promotion constitutes acceptance of the modified Promotion Terms.
- 13. Company reserves the right (but is not obligated to) in its sole discretion, from time to time, to implement detection and enforcement measures to prevent and disqualify non-compliant entries. You hereby irrevocably waive any claims against the Company in connection with any such enforcement or similar action taken by the Company.

Prizes

The winner of the Prize will be publicly announced on the above landing page as well as via email within 7 days from the end of the promotion period.
- 2. Prizes are non-transferable and cannot be redeemed for a cash equivalent. If the Prize, or any portion thereof, cannot be granted for any reason, we reserve the right (but not the obligation) to substitute such prize for one of equal, lesser or greater value.

- 3. The winners are solely responsible for reporting and paying any and all applicable taxes related to the Prizes and paying any expenses associated therewith which are not specifically provided for in the Promotion Terms.
- 4. By participating in the Promotion, you allow the Company to contact you, for the purpose of administration of the Promotion and awarding of the Prize. We will notify each potential winner by sending a notification through the email address (which was used to register to the Services), within seven (7) days from the end of the Promotion Period.

- 6. We will make a maximum of three (3) attempts to contact the potential winners within seventy-two (72) hours.
 - If we are unable to contact the potential winner within the above-specified time frame, or if such potential winner fails to sign and return the Affidavit, or is otherwise disqualified, or does not comply with the Promotion Terms, Company may revoke a participant's right to any Prize and grant it to another winner.
- 7. It is your sole responsibility to notify us in writing if you changed your contact details during the Promotion Period.

Limitations of liability; waiver and release

Additional General Terms

- 1.
